

**Bison Enjoy A Record-breaking Year!** 



Speedster Harvey Reed (16) delighted a Homecoming crowd of 18,650 as he rushed for 169 yards and four touchdowns to an easy 36–7 victory over Winston-Salem State University, Oct. 18 at Howard's W. Henry Greene Stadium.



Against Morehouse, seven different Bison players scored touchdowns for a 49-14 victory. Harvey Reed rushed for 156 yards on 14 carries, breaking a Howard rushing record of 1,012 set in 1976 by James Breakfield for a single season. Reed's total yardage after the Morehouse game was 1,023.

Homecoming 1986 will be long remembered by the nearly 19,000 alumni and friends who witnessed the Bison's victory over Winston-Salem State University 36-7, in Howard's newlyrenovated stadium named after the late Dr. W. Henry Greene, LA '20, MED '24.

On the Bison's very first possession, an option play was skillfully executed by the team's star tailback, Harvey Reed, who ran 52 yards up a sideline for the first of his four touchdowns, which tied a school record set by Melvin Sutton in a game against Cheyney State in 1982.

The win over Winston-Salem upped the Bison's mark 2-3. They had experienced a somewhat shaky start but head football coach Willie Jefferies and the Bison found the motivation to turn the corner on losing and never looked back.

The Bison proceeded to run over all of its subsequent opponents: Virginia State, Norfolk State, Morehouse, North Carolina A&T, Morgan State and Delaware State. So confident was the team's defensive linemen that they intentionally jumped offside on the games' first play expecting to intimidate their opponents. It worked.

One of the most outstanding players for the past three seasons has been Reed, a sixfoot, 170-pound junior from Miami, Fla.

Closing the season with an exciting 8-3 record indicates that football at Howard has finally come into a new era.



#### **Recent** Appointments

**O. Jackson Cole, BS '64, MS '66**, was named dean of the School of Human Ecology, replacing Cecile Edwards who became dean of the new School of Continuing Education. Cole, who had been Human Ecology's associate dean, earned his doctorate in personality psychology from the University of Michigan.

Beatrice Adderley-Kelly, Cert, Adv. Grad. Study '78, Ph.D. '86, in educational psychology, was named acting dean of the College of Nursing. She replaced Anna B. Coles who retired last June.

**Orlando L. Taylor**, former acting dean of the School of Communications, was appointed dean. He is former chairman of the department of communication arts and sciences. Taylor holds a doctorate in communications and psycholinguistics from the University of Michigan.

Lafayette Frederick was chairman of Howard's botany department prior to his appointment as acting dean of the College of Liberal Arts, replacing Robert L. Owens III, who retired last June. Frederick has a doctorate in plant pathology and botany from Washington State University.

Several new directors were also appointed. **Thomas C. Battle, BA '69**, now heads the Moorland-Spingarn Research Center where he was previously curator of manuscripts. He obtained a doctorate in American studies from George Washington University. **Dorothy M. Haith**,

a former professor at the State University of New York at Buffalo, now serves as director of University Libraries. She earned a doctorage in library science from Indiana University. George R. Rhodes, Jr. replaced Imogene Robinson as director of the Center for Academic Reinforcement following her retirement. He has served in administrative posts with the U.S. Department of Education and the District of Columbia public schools. He holds a doctorate in educational administration from Catholic University. William P. Moultrie, Howard's track coach since 1973, was named to replace Leo Miles as athletic director. Miles retired last June. Moultrie came to Howard from Stanford University and has helped to produce 49 All-Americans at Howard. He is well known for his coaching skills. He served as an Olympic coach in 1984; a 1986 national sprint and relay chairman with The Athletic Congress; and relay coach for the 1986 Goodwill Games in Moscow. Moultrie received a master's degree in educational administration from San Francisco State University.

Two appointments to President Cheek's cabinet were made to replace vacancies left by the retirement of Executive Assistant Frederic E. Davison and Special Assistant Julian R. Dugas.

Alice Green Burnette, former director of the Department of Development at Howard, has replaced Davison. She had held a similar position in development at Morehouse before coming to Howard in 1977. She is a graduate of Wheaton College.

**Robert A. Malson, BA** '70, assumed the position as special assistant to Cheek following work as acting administrator of Youth Services for the D.C. Government. He is a Harvard law graduate and served as counsel to a U.S. Senate Committee and with a local law firm.

#### Scholarship Fund Created by "BEST OF FRIENDS"

To show their appreciation for the educational experience Howard afforded them, a group of alumni known as "BEST OF FRIENDS" established a scholarship fund at Howard for students who need financial assistance.

Started among seven friends, the group has since grown. All of its members, though, graduated between 1973 and 1983.

Robyn N. Gibson, '79, the organization's president said, "The fund is only one of the things we'd like to begin doing for Howard's students. We realize that, financially speaking, things are quite different now from what they were when we were students. Fulfilling one's financial needs is tougher today."

The fund, which will be administered by the Financial Aid Office, was started with an initial contribution of \$6,500. Two awards per year, up to \$1,000 each, will be given to students who meet the following criteria:

- U.S.A. citizenship
- Enrollment in a degree program
- Junior or above, if undergraduate; second year, if graduate student
- Participant in campus life
- · Socially intelligent
- Morally responsibleIn good academic
- standing
- Demonstration of need

Applications must be submitted with a one page essay explaining why the applicant thinks he or she should be considered for the BOF Scholarship; these should be submitted to the Office of Financial Aid.

Annual events have been sponsored by "BEST OF FRIENDS" at homecoming time. "We have outgrown Washington's biggest ballroom; but we expect to be fully accommodated next year, by the new construction of larger facilities" Gibson said.

#### HOWARD'S JAZZ ENSEMBLE VISITS CHINA

The 18-member Howard University Jazz Ensemble visited Peking, China for 10 days in October. Director Fred Irby, III called it "a once in a lifetime trip."

The Ensemble was chosen to perform as part of the Royal Pacific Cultural Exchange co-sponsored by

United Airlines and Sister Cities International.

The trip was a first for jazz performers in a cultural exchange with China. It was also a first of its type between the two capital cities.

As part of the exchange, a group from Peking is scheduled to visit the nation's capital in March.

Howard's Jazz Ensemble was started in 1975. It is a training ground for students, providing large ensemble experience in the jazz idiom. It has produced an album every year since 1976; the latest is scheduled for release in January.

#### THE ROLE OF DANCE IN HEALTH OF OLDER ADULTS DISCUSSED

Gerontology and dance experts came together in the Blackburn Center Oct. 18 to explore the idea that dance can be physically and emotionally therapeutic for older adults.

ALUMNI VICTORIES IN '86 ELECTIONS Espy Takes a Seat in Congress

A. Michael Espy, BA '75, has earned a place in the annals of U.S. political history, by becoming the first black to gain a seat in Congress from Mississippi since Reconstruction. He defeated a Republican incumbent who had represented Mississippi's predominantly black Second District for two terms.

Winning with 58 percent of the vote, Espy's campaign was described as "state-of-the-art" employing the very latest technology in identifying and contacting potential voters.

His experience in state politics included service as assistant secretary of state, state land commissioner, and assistant attorney general in charge of the consumer protection division in Jackson, Mississippi. Espy, 32, obtained the juris doctor degree from the University of Santa Clara (Calif.) in 1978. He

is president of the Howard Alumni Club in Jackson.

Several other impressive victories were registered by Howard graduates.

Vicki Miles LeGrange, JD '77, captured a seat in the Oklahoma State Senate, after a record turnout of voters chose her over an incumbent in a run-off election in September. She was unopposed in the general election.

LeGrange is a former assistant district attorney in Oklahoma City. Her public sector and legislative experience also includes serving as a Congressional aide to former Speaker of the House of Representatives, Carl Albert and law clerk of two U.S. District judges.

She is an honor graduate of Vassar College and has been cited by several organizations for her community involvement and service.



David A. Clarke, ID '69 chairman of Washington, D.C.'s City Council, won reelection with the largest number of votes cast for any Democratic candidate in the city's elections. He had won all 137 precincts in the September Democratic primary. Clarke has served on the council since 1975, representing Ward I. Prior to council membership, he had a private law practice; he also was counsel and director of the Washington Bureau of the Southern Leadership Committee. He obtained his bachelor of arts degree from George Washington University.

Isiah Leggett, MA '72, ID '74, assistant dean and professor at Howard's School of Law, won an atlarge seat on the Montgo-

mery County Council in Maryland. He polled the second highest number of votes in the countywide race against three opponents. He is the first black to be elected to the County Council.

Alexander Williams, Jr., BA '70, ID '73, was elected as Prince George's County's first new state's attorney in 25 years and the first black ever to hold that office. In the Democratic primary, Williams defeated the long-term incumbent, Arthur Marshall, who received adverse reactions to the way he investigated the death of Maryland U. basketball star Len Bias. Williams beat his Republican opponent in the general election by a margin of 61 percent of the votes to 39 percent.

**Dean Hawtborne Dies** Dr. Edward W. Hawthorne, BS '41, MD '46.

dean of the Graduate School of Arts and Sciences, died Oct. 7 of pneumonia and respiratory failure at Howard University Hospital.

Dr. Hawthorne worked for more than 40 years at Howard, where he had headed the department of ... physiology for 16 years. He had served as assistant, then associate dean of the College of Medicine, and finally dean of the graduate school since 1974.

In addition to his Howard degrees, Hawthorne earned the master of science and doctorate in physiology from the University of Illinois at Chicago in 1949 and 1951, respectively. Between 1951 and 1978, he authored some 50 papers that were published in leading journals in his field.

He was instrumental in establishing the cardiovascular laboratory at Howard and the doctorate program in physiology. More than half of the nation's black cardiovascular physiologists are said to have been trained by him.

Last year Howard presented him with its Outstanding Research Award. He was also a recipient of the Distinguished Award of Merit from the Ameri-

#### First Black Woman Pb.D. Dies

Eva Beatrice Dykes, BA '14, summa cum laude, believed to be America's first black female to obtain a doctorate, died Oct. 29 in Huntsville, Ala., at the age of 93.

Dr. Dykes was born in Washington, D.C., the second child in a family of three girls. Her sisters, Anita and Florence, as well as her parents were graduates of Howard.

When she entered Radcliffe University for graduate work, credit for her degree at Howard was denied. Undaunted, Dykes completed a second bachelor's degree, a master's and a doctorate in English from Radcliffe in 1921.

Dr. Dykes returned to Washington, D.C. to teach at Dunbar High School and then at Howard for 14 years. She moved to Tennessee and taught at the former Waldon University. In 1944 she began teaching at Oakwood College in Huntsville, where she retired in 1968. She was called back to the classroom in 1970 on a full time basis for three years and then two more years on a part-time basis.

A widely published author in both educational and religious journals, Dr. Dykes began a column for the monthly Message magazine in 1934-a column which ran for 50 years. As an accomplished

musician, she accompanied some of the greatest artists in Washington and directed nationally sought choirs.

Howard bestowed its Alumni Award for Distinguished Postgraduate Achievement upon Dr. Dykes in 1945. At Oakwood a library is dedicated to her. In 1976 the National Association of Black Professional Women in Higher Education honored her as "a pioneer."

Funeral services were held Nov. 2 in the Oakwood College Campus Church, Huntsville.

**COMPUTER SERVICES OFFICE ESTABLISHED** Joseph D. Collins, BSEE '71, MCS '80, has been named executive director of a new office to oversee all university computer operations at Howard. He will also be responsible for implementing a \$30 million computer improve-

ment program that entails the construction of a new building as well as a major investment in additional materials and staff.

#### Jacques Wilson, Howard Inn Manager Dies

Jacques A. Wilson, the congenial general manager of The Howard Inn, died Sept. 5 at the Howard University Hospital, where he had been hospitalized for several months.

A native of Baltimore and graduate of its public schools, Wilson continued his education at Rock Castle Military Academy in Virginia; North Carolina A&T; and at Cornell University.

After 24 years in the hotel business, Wilson was named general manager of the Howard Inn where he culminated a career dedicated to improve hospitality management.

He was a member of the Shiloh Baptist Church Board of Trustees, the D.C. Chamber of Commerce, People's Involvement Corporation, O.N.O.'s Social Club, and past president of the United Beverage Association.

He is survived by his wife, Jacquelin; two sons, Jacques Jr. and William A. Hill; one brother, Reginald Wilson; and other relatives.






